AGENCY AGREEMENT

THIS AGENCY AGREEMENT, between WPTI TELECOM LLC. (“Agent”) and _____ (“Customer”), authorizes Agent to act as Customer’s Agent only in specific aspects of the coordination and maintenance of telecommunications services.

Customer hereby authorizes Agent to act as Customer’s Agent only in the turning up of telecommunications services between the Agent’s Point-of-Presence (“POP”) and the Local Exchange Carrier’s (“LEC”) and/or Inter-Exchange Carrier’s (“IXC”) facilities. In addition, upon Customer’s written request, Agent will provide on-going maintenance for services as specified under a separate agreement. In acting as Customer’s Agent hereunder, Agent shall only perform such activities in the way that Agent determines, in its discretion, will function most effectively with the facilities at Agent’s POP, and Agent shall owe no fiduciary or other duties to Customer in making such determination. The purpose of this Agency Agreement is only to provide LEC’s and/or IXC’s with evidence of Agent’s authority to coordinate services on Customer’s behalf and not to create any additional obligations or duties to Customer.

Customer agrees to order directly all telecommunications services, unless otherwise agreed to by the parties hereto, under separate agreement. Customer also agrees to be responsible for all charges assessed by the LEC and/or IXC for services performed on its behalf.

Customer acknowledges that the actual maintenance of telecommunications facilities is outside the control of Agent and is dependent on the scheduling of the LEC’s and/or IXC’s activities. All internal network provisioning will be the sole responsibility of the Customer.

Customer understands that Agent will be acting on Customer’s behalf only in such activities and authorizes Agent to do so at Agent’s own discretion.

This Agency Agreement may be executed in multiple counterparts, all of which taken together shall constitute the Agency Agreement. Signed counterparts of this Agency Agreement delivered via facsimile shall be treated as executed and delivered originals.
